## NOTICE OF RACE

#### 1. RULES:

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS), the prescriptions of US SAILING; the rules of the C420 Class (except as any of these are altered by the Sailing Instructions); and by the Sailing Instructions.

#### 2. SCHEDULE OF EVENTS:

#### 3. ENTRIES AND FEES:

Each vessel shall complete all parts of the online registration process and pay all fees prior to 1000 hours on Saturday, September 14. Online registration is available via TheClubSpot at the following link:

Each participant (skipper and crew) must submit a completed CBYC Parental Consent Form, signed by his or her parent or guardian, no later than 1000 hours on Saturday, September 14, 2015. This shall be delivered to the check-in desk during the designated check-in time.

The entry fee is \$65.00 for this regatta, plus a \$20 SCYYRA Perry Series Sanctioning Fee (this is the series entry fee), totaling \$85.

## Cabrillo Beach Yacht Club Parental consent for participation in the regatta and Medical and/or Dental Care of a Minor

I, the undersigned, am a parent having legal custody of other person having legal custody or guardianship of the following minor:
In consideration of said minor's participation in the regatta, I hereby authorize Cabrillo Beach Yacht Club ("CBYC") to consent to medical or dental care, or both, of said minor, including any X-ray examination, anesthetic, medical, dental or surgical diagnosis or treatment or hospital care under the general or special supervision and upon the advice of or to be rendered by a licensed physician or dentist. This authorization is given pursuant to California Family Code Section 6900 et. Seq. I agree that this authorization shall remain in full force and effect for the duration of said minor's participation in the regatta and related activities and shall not be sooner revoked.
Non-Liability of CBYC
I agree that in no event will CBYC, its affiliates, or the partners, owners, directors, officers, employees, agents, and committee persons of any of them have any liability whatsoever arising from or in connection with any medical or dental care rendered or to be rendered pursuant to the above Authorization.

Assumption of Risk
Liability Waiver and Release Agreement
I wish to voluntarily involve the above minor in the Cabrillo Beach Yacht Club's regatta. In consideration of the minor's participation in this voluntary recreational activity, I acknowledge and agree as follows:
1. To the fullest extent permitted by law, I promise not to sue, I forever release and hold harmless CBYC from and against any and all claims, damages, liabilities, losses, costs and expenses including attorney fees, for personal injury to the minor or any other person and/or loss of any property, arising from the minor's participation in the sailing program and shore side activities and any active or passive negligence of CBYC, such as negligent rescue.
2. I represent that the minor is in good health, is able to undertake sailing activities, and can swim well enough in the event his/her boat capsizes to avoid any resulting danger. I further represent that the minor is capable of comprehending instruction, following directions and observing proper safety precautions. I agree to abide by the decisions of the CBYC Officer if he/she finds it necessary to discipline or dismiss the minor for lack of attention misbehavior or failure to follow safety precautions.
3. For the purpose of the Agreement, CBYC shall include its directors, officers, employees, agents, and committee persons of any of them. If any term of this Agreement is held invalid, the remaining ter ms shall continue in full force and effect. This Agreement shall survive the termination of the minor's participation in CBYC's regatta.

I am aware that this is a broad release of liabilities agreement and I sign of my own free will without any inducement or assurance of any kind.
