

## NOTICE OF RACE JUNIOR LEUKEMIA CUP

Sunday June 2, 2019

Organizing Authority: Bahia Corinthian Yacht Club

### 1. RULES

- 1.1 The regatta will be governed by the *rules* as defined in the Racing Rules of Sailing.
- 1.2 USCG approved PFDs shall be worn at all times by competitors while on the water, other than brief periods while adding or removing clothing. The 'Y' flag will not be flown. This modifies RRS 40 and the preamble to Part 4.
- 1.3 Sabot A/B/C1 fleet boats may be subject to on-water equipment inspection upon the finish of each race. Refer to INSA class rules for a list of required equipment.

### 2. ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all junior age C420, CFJ, Laser, Laser Radial, Sabot A, B, C1, C2, C3 and RS Tera sailors.
- 2.2 Eligible boats may enter by submitting the entry form and paying the entry fee online at [www.regattatoolbox.com](http://www.regattatoolbox.com) before 5pm on Friday May, 31 2019 or in person on Sunday June 2, 2019. *Advance registration is greatly appreciated.*

### 4. SAILING INSTRUCTIONS

Sailing Instructions will be available no later than Sunday June 2, 2019 upon check-in at BCYC.

### 5. RACE VENUE AND COURSES

- 5.1 Race Venue 1: C420, CFJ, Laser, Laser Radial, and Sabot A, B, and C1 classes will sail in the vicinity of "Five Points" (turning basin).

- 5.2 Race Venue 2: Sabot C2, C3 and RS Tera classes will sail in the vicinity of the south Lido channel.
- 5.3 Courses may be a windward/leeward or any variation of a triangle course. Course diagrams will be provided in the sailing instructions.
- 6. SCORING**
  - 6.1 Three (3) races must be completed to constitute a series.
  - 6.2 When five (5) or fewer races have been completed, a boat's series score will be the total of his/her race scores. This changes RRS A2.
- 7. PROTESTS**
  - 7.1 Protests will be settled on the water using "3 Minute Justice" immediately following the race for which the protest was filed. Each party is entitled to a 1 minute presentation and judges will have 1 minute for deliberation. Unaffiliated coaches will serve as judges.
- 8. DISCLAIMER**

Sailing is an activity that has an inherent risk of damage or injury. Competitors in this race participate entirely at their own risk. See RRS 4, Decision to Race. The race organizers (OA, Race Committee, Protest Committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this race. By participating in this race, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
