**ORGANIZING AUTHORITY:** The 2024 *Fall Opti Regatta* is organized by Ventura Yacht Club.

### 1. RULES

1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS)2021-2024, this Notice of Race, and the Sailing Instructions.

### 2. ELIGIBILITY AND ENTRY

2.1. Each participant shall meet the USODA age requirements during the regatta and must be a member or participant in a youth sailing program.

2.2. Coaches/Support Persons are requested and encouraged to register for the event. There are no fees associated with this entry.

2.2. Registration is available online at <https://theclubspot.com/register/regatta/Uk0yYxbNWC/class>. Eligible boats may enter online by Saturday, November 9<sup>th</sup>, 2024, at 10:00 A.M. Registration will be online only.

2.3. To be considered an entrant in the event, a boat shall complete all registration requirements and pay all fees by 10:00 A.M. on November 9<sup>th</sup>, 2024.

### 3. FEES

3.1. There is an \$80 competitor entry fee. This entry fee includes event merchandise, a snack pack offered each day, and one dinner ticket. There will be an additional \$10 SCYYRA Series Sanctioning fee added onto each entry fee.

3.2. Entries made on or after 10:00 AM, November 6<sup>th</sup>, shall be considered late, and shall incur a \$10 Late Fee.

### 5. CLASSES

- 5.1. Available to competitors to register for are the “Championship” Optimist Fleet and the “Green” Optimist Fleet.  
5.1.1. The Championship Fleet will include Red, Blue, and White Divisions.

### 6. RACING AREA

- 6.1. The racing area will be approximately ½ mile NW of the detached breakwater outside of Ventura Harbor.  
6.1.1 A secondary racing area for Green Fleet is planned to be inside of the detached breakwater near Soter's Point.  
6.2. The race committee reserves the right to move both fleets' racing areas, as it sees fit, to maintain competitor safety.

### 7. HOSPITALITY

- 7.1. VYC's bar and restaurant will be made available to visitors during its regularly-scheduled times.  
7.2. VYC is pleased to host competitor/coach equipment, trailers, boats, etc. prior to and/or after the competition days.  
7.2.1. Any competitor or support person looking to store equipment, trailers, boats, etc., prior to and/or after the competition days must coordinate such with VYC's Waterfront Activities Manager, Braedon Baum. (Information Below)

### 8. COURSES

- 8.1. The courses to be sailed will be specified in the Sailing Instructions. Courses will use drop marks as described in the Sailing Instructions.

### 9. SCORING

- 9.1. The Low-Point Scoring System, RRS Appendix A, will be used.  
9.2. One race completed will constitute a regatta.

### 10. SHORESIDE LOGISTICS, RIGGING, LAUNCHING

- 10.1. Dry storage will be made available in VYC's parking lot for competitor boats, equipment, and Opti trailers.  
10.2. Ventura Yacht Club's hoist will be available for coach/support vessels to be launched and retrieved starting 9:00 AM on Thursday, November 7<sup>th</sup>. VYC offers its Guest Dock for coach/support vessel berthing starting 9:00 AM Thursday, November 7<sup>th</sup>, until 7:00 PM Sunday, November 10<sup>th</sup>.  
10.2.1. Secondary launching/retrieval location: Ventura Harbor Public Launch Ramp. Any persons using the Public Launch Ramp do so at their own discretion.  
10.3. Other than for loading and unloading, there will be **no** competitor parking offered at Ventura Yacht Club for the duration of the regatta; all parking must be offsite and is at the vehicle owner's discretion.

- 11.1. Competitors, Parents/Guardians in this event/series are participating entirely at their own risk. See (RRS 4) Decision to Race.
