NOTICE OF RACE



1. RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing.

2. ELIGIBILITY AND ENTRY

- 2.1. Up to 16 team entries will be accepted until January 14, 2026, at Midnight PST. Any teams to be accepted after this deadline are at the discretion of the host. Additional teams, beyond the 16-team maximum, will be placed on a waiting list. **No organization may enter more than two teams, and the host reserves the right to decide on organizational affiliation.**
- 2.2. The regatta will be sailed in CFJs provided by the host. Teams may enter by completing [sailor and coach registration online](#).
- 2.3. Each team will consist of three boats, including three skippers and three crews to qualify for entry into the regatta. Substitutions will only be allowed at the discretion of the Principal Race Officer.
- 2.3.1. **Teams registering with unconfirmed or 'TBD' sailors must update sailor information on Clubspot or provide completed roster to the OA by the entry deadline**, otherwise their entry shall be forfeited and their berth granted to the next eligible team on the waiting list, should one exist.
- 2.4. **Each registered team shall register a designated coach (or proxy), unique to that individual team, before the entry deadline. Coaches (or proxies) shall have appropriate knowledge and physical capabilities to officiate rules disputes on the water.** During each race, a minimum of two coaches from the two competing teams shall serve as umpires for that race from a shared chase boat.
- 2.4.1. **If a team does not have a registered coach that is unique to their team by the entry deadline, their entry shall be forfeited and their berth granted to the next eligible team on the waiting list, should one exist.**

3. FEES

- 3.1. Entry fee is \$220 per team.
- 3.2. Each team must also supply a \$250 damage deposit in the form of a check, credit card authorization form, or SDYC member number prior to the close of check-in on Sunday, Jan 18.
- 3.3. Entry fee includes usage of provided boats and sails, trophies for the top three finishing teams and lunch on Sunday only.
- 3.4. Each team will be sent a lunch order form to submit online before the regatta. Boxed lunches will be available for pick up at check-in on Sunday morning.

- 4.2. The regatta format and the number of races will be determined by the Principal Race Officer and will be based on the number of teams registered and the weather conditions. Possible formats include but are not limited to: Round Robin, Split Fleet Round Robin, and Elimination Ladder, followed by quarterfinals, semifinals, and finals. The format to be attempted, contingency formats (if any) and changes to the format will be posted on the Official Notice Board located on the east side (facing the water) of the Burnham Sailing Center.

5. SAILING INSTRUCTIONS

- 5.1. Sailing Instructions will be provided at check-in.

6. VENUE

- 6.1. The intended racing area will be in the La Playa basin between San Diego and Southwestern Yacht Clubs. Rotations will be off the SDYC Race Dock (E) and viewing is available from the docks and shore.

7. COURSES

- 7.1. The course will be any variation of the digital N-course.

8. EQUIPMENT

- 8.1. Club Flying Juniors and sails will be provided by the host.
8.2. Boats will be rigged and inspected prior to the first race as part of a team's Check-In process.
8.3. Each team's registered coach must be present to access or use equipment throughout the duration of the event.
8.4. Standing rigging shall not be adjusted without prior permission of the Regatta Chairmen and, if applicable, the Chief Umpire/Judge.
8.5. Competitors will be responsible for damage to boats as a result of a foul or negligence.

9. AWARDS

- 9.1. The winning team will receive the SCYA Harold Adams Team Race Perpetual. Top three teams will receive awards.
