1 RULES

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2025-2028 (RRS).
- 1.2. The rules of the [CFJ Class Association](#), the [Shadden Series Standing Rules](#), the [2025- '26 Shadden Perpetual Trophy Series Notice of Race](#), the Notice of Race published for this event (except where modified by the Sailing Instructions), and the Sailing Instructions will also apply.

2 ELIGIBILITY AND ENTRY

- 2.1. This regatta is open to CFJ Class boats that meet the following requirements:
 - a. The skipper and crew shall be under 19 years of age and shall not have entered college.
 - b. The skipper and crew shall be members of an SCYA or SCYYRA recognized yacht club.
 - c. One crewmember on each boat must be a member, in good standing, of the CFJ Class.
- 2.2. All competitors must be registered for the 2025-2026 SCYYRA Shadden Series. Registration is free and can be completed at [2025-2026 SCYYRA Shadden Series Registration](#) (for ease of use, please use the Chrome browser).
- 2.3. Registration will be available at sdyc.org/juniors. Entry fees include a snack during trophies and SCYYRA Shadden Series sanctioning fees.

4 SAILING INSTRUCTIONS

- 4.1. The Sailing Instructions will be available at check in.

5 RACING

- 5.1. The racing area will be approximately 1 NM southeast of Zuniga Jetty in the area known as the Coronado Roads. Depending on weather conditions, the racing area may be moved to a more sheltered location in the San Diego Bay.
- 5.2. Sailors should be prepared for a long day on the water. Lunch IS NOT provided.
- 5.3. All boats must have a CFJ-class-legal tow line for towing purposes.

6 COURSES

- 6.1. The courses to be sailed will be as follows: windward-leeward, triangle or any combination thereof.

7 PENALTY SYSTEM

- 7.1. RRS 44.1 and 44.2 shall apply.

8 SCORING

- 8.1. This regatta will be scored as provided in RRS Appendix A using the Low Point System modified such no scores shall be discarded.
- 8.2. Two races will constitute a regatta.

9 SUPPORT/SPECTATOR BOATS

- 9.1. Spectator boats will not be provided.
- 9.2. Team leaders, coaches and other support personnel shall stay outside areas where boats are racing from the time of the preparatory signal until all boats have finished the race or the race committee signals a postponement, general recall, or abandonment.

10 TRAILERS

- 10.1. All trailers should be stored in the lot adjacent to the dinghy dry yard; any trailer parked along the side fence may be moved at the discretion of the dockmaster.
- 10.2. Competitors must provide their own dollies, and all boats must be clear of the fire lanes.
- 10.3. Support boats will be berthed in the whaler slip adjacent to the Jr. Dock. No boats may be tied up in private slips.

11 TROPHIES

- 11.1. Trophies will be awarded to the skipper and crew of the top five teams at the regatta.

12 DISCLAIMER OF LIABILITY

- 12.1. Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

13 HOSPITALITY

- 13.1. There will be snacks for competitors after racing.
